CAROLINE'S LEGACY

In our last newsletter we reported the devastating loss of our beloved friend and Board Secretary, Caroline Harsant Whitley. Caroline had been a very active and involved volunteer for over 6 years when she lost her courageous battle with cancer in September. Caroline's family graciously asked for memorial donations to be made to The CARE Clinic in recognition of Caroline's passion for our mission. The response was absolutely outstanding. In 29 short years, Caroline obviously touched many people with her gentle nature, optimistic attitude, and true inner beauty. As of December 31st, Caroline's family and friends have donated over \$25,000 to our Clinic, sponsoring exam room #4 in her memory.

As a tribute to Caroline, The Pollitt Selection offered to frame a picture to place in her room so that for years to come patients and visitors would be able to see the beautiful young woman the room was named for. This idea was so well received The Pollitt Selection generously offered to frame a picture of each named gift honoree. A subcommittee is collecting the pictures and they are also putting together an album with articles about our honorees so their stories will be preserved for the future.

An accomplished artist, Caroline's twin sister, Laura Harsant Reeves, found a unique way to use her talents to honor her sister's memory. Caroline collected inspirational sayings that helped encourage her and uplift her spirits as she battled brain cancer. With the encouragement of family friend, Joan Poole, Laura selected 29 of Caroline's favorite quotes (in honor of Caroline's 29 years of life) and designed CARE's Coasters. Joan provided the supplies and Laura began hand painting each tile with one of the sayings and often a little decoration. Joan set up a display with Caroline's story at her store, The Pilgrim Gift Shop in Westwood Shopping Center. The sales of the coasters, designated to benefit The CARE Clinic, far exceeded Joan and Laura's expectations. Despite holding a full time job and having a husband and baby to take care of, Laura's love for her sister helped her continue on every time Joan called for more coasters. At the December Board of Director's meeting, Laura and Joan proudly presented \$3,500 from the coaster sales to Board President Brenda Booth. They increased the excitement by presenting each person at the meeting with one of the coasters. Everyone had great fun remembering Caroline and sharing the quotes on their coasters.

Caroline's family is extremely close and supportive of each other so it is not surprising Caroline passed her passion for our mission on to her family. Her husband, Greg Whitley, helps us with his legal opinion whenever we need it. Her brother, Stewart Harsant, volunteered with us during the summer while he was in college. Now back home to attend physician assistant school, Stewart has returned to volunteer as a Certified Nursing Assistant. Caroline's mother Pam Harsant, a registered nurse, also volunteers during our evening clinics.

The CARE Clinic was truly blessed to have Caroline choose our organization as the place she wanted to share her time and talents. We continue to be encouraged by her inspirational quotes, and we take great comfort in knowing The CARE Clinic has our own special guardian angel in heaven watching over us. God bless you Caroline. 2 Day Free Dental Clinic

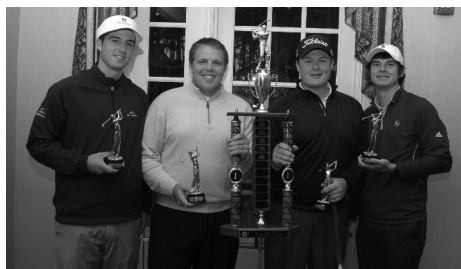
The NC Missions of Mercy will be holding a two day free dental clinic in Fayetteville for the first time June 29-30! The North Carolina Dental Society's portable outreach program provides free dental services to those in financial need with few or no other options. Thankfully we were able to convince The NC Missions of Mercy (NCMOM) we have both the need and resources to hold a successful clinic here.

The 80 chair Free Dental Clinic will be held at the Agri-Expo Center. Clinic hours will be 6 AM – 5 PM on Friday, June 29, and 6 AM to 3 PM on Saturday, June 30. Patients typically begin lining up the night before to make sure they are able to be seen. The two day clinic will provide services to approximately 1,200 needy patients.

The NCMOM program depends on volunteers to staff the clinics, and donations to cover expenses such as the supplies needed to treat so many patients and transporting all the dental equipment. SR-AHEC Residents Volunteer at The CARE Clinic

Ever since Eron Manusov, M.D. arrived as the director of the Duke/Southern Regional AHEC Family Medicine Residency Program, he has stressed community service as integral to the learning process and growth of medical residents into well-trained, competent physicians. He introduced his idea to new interns who arrived in June, and let them choose where they would serve to fulfill their community rotation curriculum requirement. Resident Philippe

Bulaitan, M.D. picked The CARE Clinic and Dr. Manusov joined him. On Tuesday, December 13th, the two physicians were the first pair from the program to provide volunteer clinical services at The CARE Clinic through a community rotation. "To be a physician is to serve," Dr. Bulaitan commented on why he chose The CARE Clinic for his community rotation. "Service to the community, service to education, service to those who need it, are reasons why I practice medicine," he said. "This experience allows the physician to serve, and it teaches us to always find opportunities to serve." Dr. Bulaitan recommends The CARE Clinic rotation to his fellow residents. "Not only do you get a chance to care for patients who are grateful and need care, but you get to experience a wide variety of illness," he said. "The warm fuzzies are great also."

Dr. Bulaitan was impressed to find The CARE Clinic a place with all the amenities of a funded clinic. "I also found great people with a passion to care and great patients who needed care," he said. For Dr. Manusov, The CARE Clinic offers the chance for the faculty/resident team to maximize the quality of care for patients although resources are limited. "This allows me to teach residents how to care for

patients without spending a lot of money," he said. "It shows them that we can still do an outstanding job, with less." Both Drs. Manusov and Tinsley Rucker, volunteer Medical Director for The CARE Clinic, are excited to have the Duke/SR-AHEC residents join Womack Army Medicine Center's Family Medicine residents, who already do their community rotations at The CARE Clinic. "This way, they will all get to know each other, get to know the physicians in the community, and hopefully convince them to stay in our area to practice," Dr. Rucker commented at the December meeting of The CARE Clinic Board of Directors.

Dr. Manusov believes that working with the military will help his residents have a better understanding of rural medicine, which is a major emphasis of the Duke/SR-AHEC program. "It makes sense to work together," he said. "Deploying to a small base is similar to working in a rural community; we can learn a lot from the military physicians who feel very comfortable working in rural America. It's a good approach in convincing them to work in rural communities, where there is the most need for primary care physicians."

Volunteer Pharmacy Director

We are pleased to announce Scott Donaghy has agreed to serve as our Volunteer Pharmacy Director. Scott replaces Martha Epps who has served as our Volunteer Pharmacy Director since 1999. Scott has been volunteering with The CARE Clinic since April 2002. In addition to volunteering during evening clinics, Scott runs the pharmacy for Dr. Izurieta's Tuesday afternoon clinics, and comes in during his free time to mix Dr. Shereff's special dermatology cream. Last year Scott was named our Clinical Volunteer of the Year during our annual Volunteer Appreciation Dinner.

In addition to volunteering his skills, as Volunteer Pharmacy Director, Scott is responsible for the pharmacy aspects of patient care at the clinic. He serves as a member of the Clinical Services Committee and a member of the Board of Directors.

Thank you, Scott, for your willingness to serve as our Volunteer Pharmacy Director. We appreciate all you do to support our mission and look forward to working with you in your new role.

"The hospital recommended the clinic to me. I would have nowhere to go because the Health Department told me they couldn't see any new patients. You all have been a great blessing for me. This was my first visit to The CARE Clinic. Everybody was very friendly and cared about what was going on with me. I wasn't able to come here. I love all the people here! It has been a great help for me and I have always been given good care here. The staff is very professional and the facility is clean and pleasant. I thank you all."
