Cathy Riddle

The CARE Clinic is pleased to welcome Cathy Riddle as our new Clinical Director. Mrs. Riddle is a dedicated, skilled RN with a broad range of experience. She received both her Bachelor's and Master's Degrees in Nursing from Thomas Jefferson University in Philadelphia, PA. Mrs. Riddle is a native of Philadelphia and came to Fayetteville in 1991 when she was recruited to be the Clinical Nurse Specialist for Surgery at Cape Fear Valley Health System. She has served as evening charge nurse at several different hospitals, Director of Continuing Education at Southern Regional Area Health Education Center, Administrative Coordinator at Fayetteville Ambulatory Surgery Center, and Risk Management, Corporate Compliance and Nursing Quality Coordinator at Cape Fear Valley Health System.

Mrs. Riddle volunteered at The CARE Clinic from 1996 until 2005 when her time was needed to help care for her elderly mother. Now back at The CARE Clinic she is thoroughly enjoying getting to know all the volunteers, patients and coworkers as she settles into her new position. "The CARE Clinic is an amazing place to work, you never know what miracle is going to happen next", she reflects. "One day we are discussing the fact that some supplies are getting low and the next thing we know, a couple of school buses arrive with enough supplies to fill up the waiting room. Another night the Medical Director reviewed some lab work and said the patient really needed a Nephrologist. At the end of the clinic, that same night, a man came through the front door, introduced himself and said he was a Nephrologist and wanted to volunteer at The CARE Clinic."

Mrs. Riddle is married and in her spare time volunteers at Good Shepherd Catholic Church teaching Baptismal prep classes to parents, Safe Environment Training to adults who work with children, and serving as a Eucharistic Minister and Lector. She also loves spending time with family and being by the water whether it is swimming at the HealthPlex, kayaking on the lake or relaxing at the beach.

OPERATION WALK USA

Dr. Dickson Schaefer, an Orthopaedic Surgeon, contacted The CARE Clinic last fall for assistance in finding a good candidate for Operation Walk USA. The program provides free hip or knee replacement surgery to patients who do not qualify for government assistance and cannot afford surgery on their own. Within a week we referred a potential patient to him. After examining our patient and running some tests, Dr. Schaefer agreed "James" was an ideal candidate for the free surgery.

"James" had always been active, playing sports and exercising to stay healthy. Now at 56, "James" had an extremely bad case of arthritis in his hip and could barely walk. He had lost so much time at work he eventually lost his job, and his health insurance. He turned to The CARE Clinic for help and received more help than he had dared to dream about.

Thanks to Operation Walk USA, Dr. Schaefer, and Cape Fear Valley Health System, "James" received his free hip replacement surgery on December 1. Months of physical therapy followed but "James" is walking, and smiling, again. Grateful to be out of pain, "James" says "This surgery was a blessing."

VOLUNTEER APPRECIATION
