## 20TH ANNIVERSARY CELEBRATION

The CARE Clinic celebrated 20 years of service with a special dinner at Snyder Memorial Baptist Church's social hall on Saturday, November 16th. Volunteers, donors and supporters from the past 20 years gathered to reconnect, reminisce and reflect on how quickly time has passed and how many patients have been helped in that time.

The program kicked off with a lively presentation of a cappella songs by the talented 82nd Airborne Chorus. A video from Moonlight Communications chronicling the history of the clinic was then debuted.

The highlight of the evening was hearing Sister Jean Rhoads, the founder of The CARE Clinic and original Executive Director, speak of the miraculous work of the clinic, with volunteers providing free care to thousands of uninsured residents of Cumberland County over so many years. As she expressed so well, "The CARE Clinic would not have a heartbeat without each and every one of you." Patients are truly treated with compassion as evidenced when the hospital called Sister Jean to say a patient had listed The CARE Clinic as his family.

Cumberland County Commissioner Ken Edge presented Sister Jean with a framed Cumberland County Care Award citing her "gentle guidance and undeniable charisma" in founding the clinic. Executive Director, Cathy Ory, then presented Sister Jean with token of appreciation for traveling from St. Louis to be with us for this momentous occasion. The gift, which holds special meaning to all of us at The CARE Clinic, was a CARE's coaster with Caroline Harsant Whitley's favorite quote, "Do what you can, when you can, because you can."

We would like to express sincere appreciation to everyone who served on the Anniversary Planning Committee for the great job they did planning and decorating for the dinner. The evening was a tremendous success that was greatly enjoyed by everyone who attended.



## PAYING IT FORWARD

Shortly before Christmas, a woman came to our door and said she wanted to make a donation. When she came in, she told us she had come to The CARE Clinic for help many years ago, shortly after we opened. She had been diagnosed with breast cancer and every time she had chemotherapy her gums bled and her teeth were falling out "like they were baby teeth." She had read about our clinic in the newspaper and came to see if we could help her. Although we didn't provide dental services at that time, the staff had shown her great compassion. They brought her in and provided words of comfort while working on a referral to UNC Dental School in Chapel Hill. They were able to save her teeth and she had never forgotten what The CARE Clinic did for her. At the time she came here for help, she was working "for the man". She had since retired but after several months decided that was not for her, so she opened her own business. Her business was doing very well so she came back to the clinic to make a donation as a thank you for helping her so many years ago. She blessed us with a check for \$1,000.

# VOLUNTEER SPOTLIGHT



Scott Donaghy has been volunteering as a pharmacist with the clinic since April 18, 2002 and has amassed an amazing 864 volunteer hours! In 2002 we were in desperate need of pharmacists, often having no pharmacists volunteering on a clinic night. We were sending patients to a local pharmacy and paying for each prescription which was too expensive to continue doing long term. Scott

was approached while on his job at a local pharmacy. He signed up then and there to volunteer and has been doing so ever since. He is a very dedicated worker who goes above and beyond what is expected of him and keeps things lively here at the clinic.

Scott received the Clinical Volunteer of the Year Award in April 2011. That same year he joined the Clinical Services Committee and in

November became our Volunteer Pharmacy Director and joined the Board of Directors. In 2012, one week before our first NC Missions of Mercy Free Dental Clinic, we found out MOM's volunteer pharmacist was not coming. We were reluctant to have so many patients with major dental work go without the medications they needed so we asked Scott to help out. He quickly got the appropriate clearance from the Board of Pharmacy, ordered the medications, organized volunteers to help pre-package the prescriptions, and got volunteer pharmacists to help staff the event. In July 2013, he was asked to chair the Clinical Services Committee and agreed.

Another one of his talents is baking and lucky for us, he tries new recipes out on the staff and volunteers. It is a rare time when he shows up at the door for Tuesday afternoon's chronic care clinic without a bag of cookies in his hands. He even made mini-cheesecake squares and macarons for our wine tasting event this year! He is an all-around great guy and we are so happy that he was persuaded to become a volunteer at The CARE Clinic!

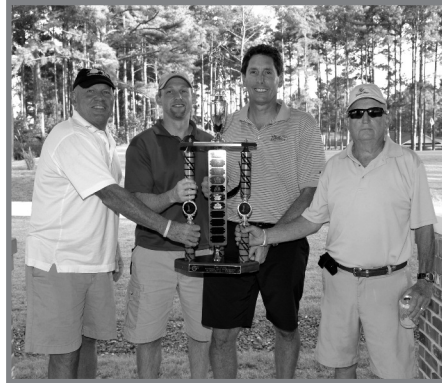

## 3rd MOM FREE DENTAL CLINIC UNCERTAIN

For the past two summers The CARE Clinic, Fayetteville Area Operation Inasmuch and Better Health have co-hosted the NC Dental Society's Missions of Mercy for a massive free dental clinic. The two day event, held at the Crown Agri-Expo Center is an 80 chair free dental clinic that offers cleanings, fillings, extractions, and front partials. At our first clinic, 1,006 patients received dental services valued at \$684,470. This year, 855 patients received services valued at \$496,983. The need for dental services is clearly evident as patients line up and wait through the night to receive care they otherwise would have to do without because they can't afford it.

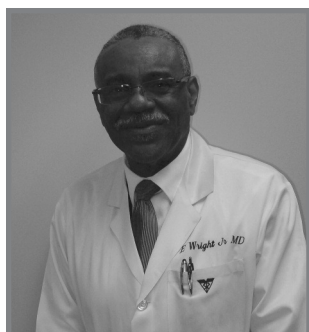
In October, host communities were invited to Cary to meet with the leadership of the NC Dental Society to discuss the future of the MOM clinics. We were informed it costs \$75,000 to hold the typical free dental clinic. The Dental Society does not have the financial resources to fully fund multiple MOM clinics so host communities are now being asked to sign a formal agreement with the Dental Society stating they will

raise a minimum of \$48,000 in cash and/or in-kind donations. If the community cannot raise the requested amount, the clinic will either be cancelled or postponed to a later date.

Our local Planning Committee discussed the new requirement and decided to take a "leap of faith" in planning for another clinic in 2014. We have tentatively reserved the Agri-Expo Center for a third MOM Free Dental Clinic on August 1-2. We know we will have the patients and volunteers needed for the event. Whether we will be able to raise the funds we need is yet to be seen. Donation checks must clearly be marked for the NC MOM Free Dental Clinic.

We sincerely hope we will be able to offer this tremendous service to our community once again and appreciate all the help we can get to make this happen.
