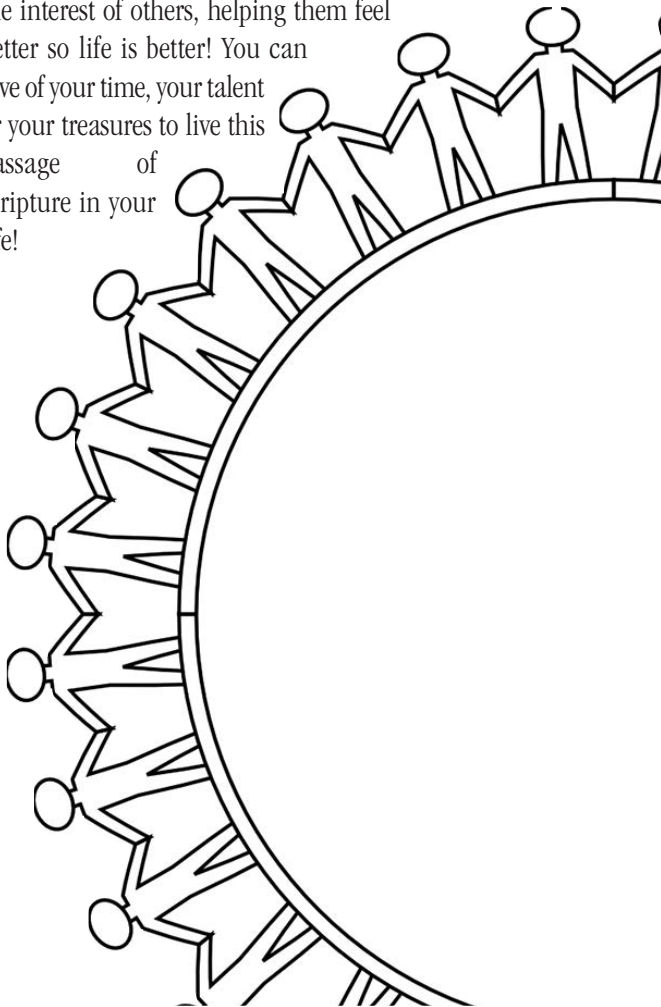

ATHENA HEALTH

When The CARE Clinic opened in 1993, there were no software programs available to non-profits for screening and scheduling patients or for gathering patient statistics and donor records. A wonderful volunteer, John Reichart, developed programs for us in an a Microsoft Access Database, and we have been working with those programs for the past 23 years. Technology has advanced so much and so many programs are now available, we are finally (and slowly) transitioning to newer, more useful, programs.

In our most recent venture The CARE Clinic recently started using a new program for scheduling and tracking patient statistics. We asked advice from the NC Association of Free and Charitable Clinics and were given the contact information for Athenahealth. The program is designed to be used for scheduling office visits, electronic medical record (EMR) documentation and billing. We do not utilize the EMR or billing but have started using the scheduling and inputting information from patient visits that can later be used for reporting. We were delighted to hear we would be able to utilize this program for free through the AthenaGives program! Any free or charitable clinic that does not bill insurance is eligible to participate in the athenaGives program. This is a web based product and the support is available online and by phone. There were weekly and biweekly live sessions with support to get started, as well as online tutorials that can be accessed at our convenience. There is also online or telephone support readily available.

The athenahealth website states, "Here at athenahealth, we've always been focused on our mission of building trust with health care providers, helping them do well by doing the right thing. Our Corporate Citizenship program, athenaGives, goes above and beyond, connecting patients to high quality care even in the absence of market incentives."

Some statistics on the website state that since the program's founding in 2010, Athena has:

- Donated more than \$1.5 million to local nonprofits
- Helped volunteer providers see more than 45,000 unique patients in free and charitable clinics across the U.S.
- Documented nearly 10,000 unique patient encounters in Haiti

We are still in a transition period and cannot get patient statistics until we are fully integrated into the program. Once this is accomplished, you will see the patient statistics on the back page of the newsletter again. Thanks for your patience while we work through this process! We are looking forward to working with this program and athenahealth in the future.
