Volunteer of the Year Awards were presented in five categories:

The **Administrative Volunteer of the Year** award was presented to Wanda Wynn, who has volunteered as a receptionist during evening clinics and has put in nearly 600 hours since 2008. She is responsible for checking patients in, getting their chart ready for the provider, and making follow up appointments for the patients before they leave. ## UNINSURED AFTER THE AFFORDABLE CARE ACT

Although it is true the Affordable Care Act (ACA) will enable some low-income individuals to obtain health insurance, it is also true 23 million or more will remain uninsured. The need for charity care programs, like The CARE Clinic, that provide low income, uninsured with access to low or no cost health care services will continue. This is particularly true in North Carolina and the other 25 states which did not expand their Medicaid program. In nearly every state not expanding, childless adults will remain ineligible for Medicaid. Many of these low income adults will fall into a "coverage gap" – unable to

afford insurance and not qualifying for a subsidy. Further, they will probably qualify for one of the many exemptions and not have to pay the fine for being uninsured.

For the past 20 years, The CARE Clinic has helped low-income, uninsured patients receive the healthcare services they need to get well, keep their jobs, care for their families, and reduce their inappropriate use of high cost sources of care. While the ACA may change the numbers and demographics of the uninsured, the need for charity care programs like The CARE Clinic will stay the same, providing quality healthcare to those low-income uninsured individuals with no other access to care.
