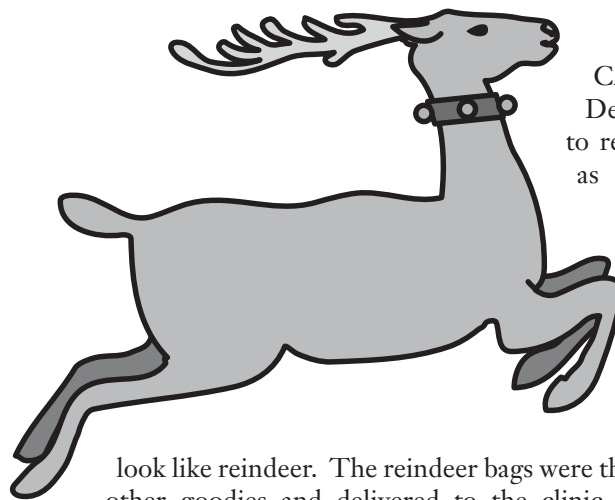

CHALLENGE GRANT UPDATE

In our last newsletter we announced Cumberland Community Foundation had issued a challenge grant for the construction of our new clinic. Our challenge is to raise \$82,500 in local donations in order to receive a \$27,500 grant from the Foundation. As of January 31st, we have received donations totaling \$54,503 specifically to help us meet this challenge. We need an additional \$27,997 in order to receive the full match from the Foundation.
