# TURNING POINT

Violet had been calling faithfully every Friday morning for several weeks. Finally she got through in time to get one of the precious dental appointments for a Tuesday night dental clinic. Violet showed up early and was the first patient called to have her x-rays taken. When the dental technician asked which tooth Violet wanted pulled, she replied "All of them."

Katheryn Jenifer, our Clinical Director, met with Violet and learned she had recently been diagnosed with cancer. Only 49, Violet was told she had to have all her teeth pulled before she could start radiation therapy. She had applied for Medicaid to help with her cancer treatment, but she had not been approved yet. Anxious to start treatment for her cancer, Violet had turned to The CARE Clinic for help.

Twelve dental patients were scheduled for extractions that night. Katheryn was concerned that a full mouth extraction was a little more involved than what volunteer dentists needed to be doing during an evening clinic, so she called Dr. Hodges, one of our volunteer dentists who she knew worked late hours at his office. When he heard Violet's story, Dr. Hodges told Katheryn to send Violet to his office right away. Dr. Hodges and his staff performed the full mouth extraction for Violet that night, and she was able to start her cancer treatment the following week.

Violet says she had been receiving so much bad news, a diagnosis of cancer, being told she needed to have all her teeth pulled, having no insurance – she was desperate and nearly in a panic. Coming to The CARE Clinic and seeing Dr. Hodges were the turning points for her. Violet is now receiving treatment and is optimistic about her recovery.

## Donated Medical Supplies

The CARE Clinic is blessed to receive donated medical equipment and supplies from a variety of different sources. Families of patients who have passed away often donate medical items that have never been used but cannot be returned. Fortunately for needy patients in our community, the families generously decide to pass them on to someone who might be able to use them rather than just throw them out. One such donor, Mr. Truman Bullard donated a substantial amount of supplies in January in memory of his late wife, Alice Faye Bullard. These items are shared with grateful CARE Clinic patients who can use them or are given to other local non-profit agencies that will give them out to patients in need.

Churches and civic groups also provide supplies as a group project. The CARE Clinic provides dental kits containing mouth care instructions, gauze, toothpaste and a toothbrush, for every patient who is seen at The Clinic for a tooth extraction. First Presbyterian Church took this on as a project for the youth participating in the mission conference February 4 – 6 and donated 500 dental kits for our patients. Readers of “The Samaritan” also occasionally donate medical items from our “Wish List” that is published in every newsletter.

In-kind donations like these help us to stretch our limited funds further in providing care to our uninsured patients. We want to thank everyone who has donated medical supplies to the clinic. We appreciate your thoughtfulness and generosity!
