## VOLUNTEER APPRECIATION

The CARE Clinic's Annual Volunteer Appreciation dinner on April 6th was again hosted by Berean Baptist Church, which has graciously provided use of their fellowship hall and a delicious meal for the past four years. Joey Boles, President of the Board of Directors, enlightened everyone with a presentation on

the African word *Ubuntu* - the essence of being human. He described how the qualities of *Ubuntu*, including generosity, respect, and trust defines CARE Clinic volunteers.

Volunteer of the Year Awards were presented in five categories:

The Administrative Volunteer of the Year award was presented to Dot Fitzgerald. In 2007, Dot called to offer her services to us and has been helping us with data entry and special events ever since. She has helped with registration at our Golf Tournament for the past two years and has designed flyers and forms for this event as well as our Annual Wine Tasting. She has even stepped outside her comfort zone by obtaining new sponsors for our fundraising events. A former bookkeeper, Dot is very organized and pays much attention to detail. She has done such an outstanding job of getting our health professional volunteers' credentials files in order that we are now in a position to proceed with applying for accreditation from the NC Association of Free Clinics. Dot has become an unpaid member of the staff coming in almost every day all day.

The Clinical Volunteer of the Year was presented to Dr. Thang Le. Since 2003, Dr. Le has been volunteering as a dentist during evening clinics at The CARE Clinic. He has logged in nearly 270 hours since then. In addition to staffing the dental clinics twice a month with Dr. Chupkowski and the dental residents from the VA Medical Center, Dr. Le frequently helps us out when a scheduled dentist cancels out at the last minute.

The Group Volunteer of the Year award was presented to Cross Creek Imaging. Since 2007, Dr. Scott McGraw and his staff have donated nearly 150 specialized radiological tests for CARE Clinic patients. The staff is very easy to work with when making appointments for our patients and results are received in a very timely manner.

The Community Volunteer of the Year was presented to Karen Mantzouris. Karen met Cathy Ory at an M.J. Soffe health fair in 2004, joined our Education Committee and soon became its chairperson. She offered her help to other committees at the clinic and became so involved with Community Relations Committee that she is now the chairperson of that committee and the two committees have joint meetings every month. Karen and her committees were instrumental in planning the Dedication Ceremony for our new building, our recent Donor Appreciation event, and power point presentations for various events. They have also assisted with numerous fairs and presentations, which has increased our visibility in the community.

The Military Volunteer of the Year was presented to Dr. Jeffrey Almony. Dr. Almony started volunteering with us in 2005. Recognizing that our contract to have third year Family Practice Residents from Womack Army Hospital coming to The CARE Clinic as part of their clinical rotation was mutually beneficial, Dr. Almony took it upon himself to pursue a similar contract for the dental residents. In October 2008, we signed a contract with Womack which provides for the Oral and Maxillofacial Surgery Residents to staff The CARE Clinic one evening each month.

## ANDY AUGUSTINE *Remembered*



The CARE Clinic lost a long time friend, supporter, and volunteer when Andy Augustine lost his courageous battle with cancer in February. Mr. Augustine joined our Development Committee in February 1997 and quickly became a very active and committed volunteer. In April 1998, Andy introduced a new fundraising strategy for The CARE Clinic which encouraged local firms to donate to The CARE Clinic instead of purchasing holiday gifts for their clients. In return the clinic would send a special card to the clients notifying them a gift to The CARE Clinic had been made in their honor or in memory of their loved one. An Investment Representative, Andy led by example and delivered his own long list to us every year, and encouraged his business associates to do the same. Since its inception, Andy’s Holiday Card Program has raised nearly \$46,000 for the clinic! This past year alone we received record donations totaling \$9,562!

Andy was elected to our Board of Directors in 2003 and would have completed his second three year term this year. He attended most of our meetings, usually sitting in the same spot, leaning back in his chair with his arms folded across his chest. He would quietly take everything in and then suddenly interject a pearl of wisdom which usually offered a point of view we had not considered yet. Board members fondly remember his wonderful sense of humor and the expert financial advice he generously shared with us.

The CARE Clinic was truly blessed to have Andy Augustine as a loyal volunteer for so many years. We are a stronger organization because of Andy sharing his time, talents and treasures with us. He was a valued member of our CARE Clinic family and he will truly be missed.

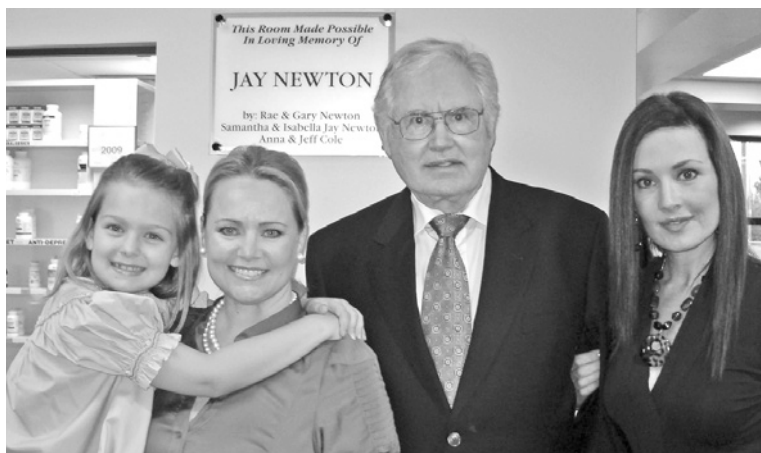

We were also fortunate to have the Fayetteville Observer do a wonderful story on our clinic on the front page of the Local Section on March 26th. The article featured one of our patients who recently lost her job and suddenly found herself on unemployment and without health insurance. Although Cumberland County has not had any major employer close their doors, The CARE Clinic has noticed a marked increase in the number of calls recently unemployed people like the patient above. We are fortunate to have loyal supporters who have enabled us to continue to provide health care to those less fortunate among us.
